Burton’s Cove Logging and Lumber Lock Out Tag Out Initiative

Working around energized equipment poses a severe hazard to all workers. The injuries can range from a small cut or bruise to amputations and even death. Maintenance (preventive or repairs), making adjustments and removing jams are some of the reasons people reach in or get into equipment that is not properly locked out. They put themselves in harms way without properly locking out equipment because of the “it can’t happen to me” or “it will only take a second” mentality. It only takes a second to get caught in a piece of equipment and yes it can happen to you.

Unfortunately, too many people are injured and killed each year as they fail to recognize the hazards involved with working on equipment not properly locked out or they blatantly disregard them.

When it comes to lock out procedures a lot of people are intimidated by the

thought of putting a program in place and others may overlook an important step. That is why FSANL completed a pilot project with Burton’s Cove Logging and Lumber (BCLL) to create a generic lock out program for a sawmill and then make it available to the whole industry. Sawmills can then take the program and tailor it to their operations. BCLL is now in the final stage of implementing their program. FSANL is pleased to have had the opportunity to work with BCLL to complete this very important project.

In order to have a lock out program for your mill use the following steps to help you get started.

If you require any assistance please feel free to contact FSANL at any time.

Steps to build your LOTO program

- Identify need for procedures.

- Do audit on mill to identify what work is needed. (Guarding, energy sources, labeling equipment, etc.)
- Complete work from audit.
- Write LOTO procedures.
- Develop training program. (Written procedures, Power-Point)
- Purchase equipment needed. (Locks, scissors, tags, etc.)
- Train workers.
- Do regular audits to ensure procedures are being followed and any problems in the system are identified and corrected.

Bite Back Against Frostbite

With the winter months upon us it seems fitting to address a topic that affects everyone, from construction workers to men and women clearing their driveways. From ice fishing to racing toboggans. Something all people of Canada face, Frostbite. Our bodies work hard to keep internal organs and our head warm. But, toes, fingers, ears, and your nose are the areas most susceptible to frostbite. These areas are quick to become affected which is why it is very important to be able to notice the

signs to prevent harm to yourself or people under your care. Usually, when parts of your body get cold, they turn red and sting. Symptoms of frostbite, however, include a loss of feeling and lack of color. Extremely cold temperatures can cause hypothermia, which occurs when the body's internal temperature dips below 35 degrees Celsius. Warning signs include uncontrollable shivering, memory loss, disorientation, incoherence, slurred speech, drowsiness, and obvious exhaustion.

In Newfoundland, on the average winter day, frostbite can occur within 7-12 minutes on bare skin so to prevent Frostbite or Hypothermia it is important to keep internal body temperatures sustained around 37 degrees Celsius, turn on your car heaters, wear warm clothing, wear heat packs, and routinely find shelter from harsh winds. Keeping warm will ensure a safe and enjoyable winter season!
